## a. Website – Terry

Terry talked about the new web site and Big Teams. He mentioned that he thought the prices they want for maintenance might be OK, there is some clunkiness and support has been slow at best. Terry has finally been able to make contact with the company that we invested the \$25k with. Their name was First Investors, now known as Forresters. Sue Perry is our contact agent. Current value of the account after two years is \$23,970. He has had the contact changed to his address.

# **d. Sponsor Updates** – Craig

Craig says he has had commitments from a number of vendors. Need to keep working at contacting vendors. There is continued concern about the conflict with WADA Conf. at the same time as OADA. Craig also expressed continued confusion over the levels of sponsorship among the major sponsors. We can find no corporate sponsor agreements thus are developing this as we go. With the downsizing of Big Team's commitment, the need for increasing the number of corporate sponsorships was expressed by many. We are feeling that new revenue must be found to keep the cost of the conference down as well as meet our commitments. We will discuss ideas at our December meeting and come up with a plan to recruit sponsors at the NADA in Nashville.

Tim emailed us an updated revision of what he is working on. Some discussion & reshuffling regarding the OSAA Classification committee public meeting. Discussed costs for Jay Hammes, whether we want to attempt to bring out Joe Ehrmann author of Inside/Out Coaching.
